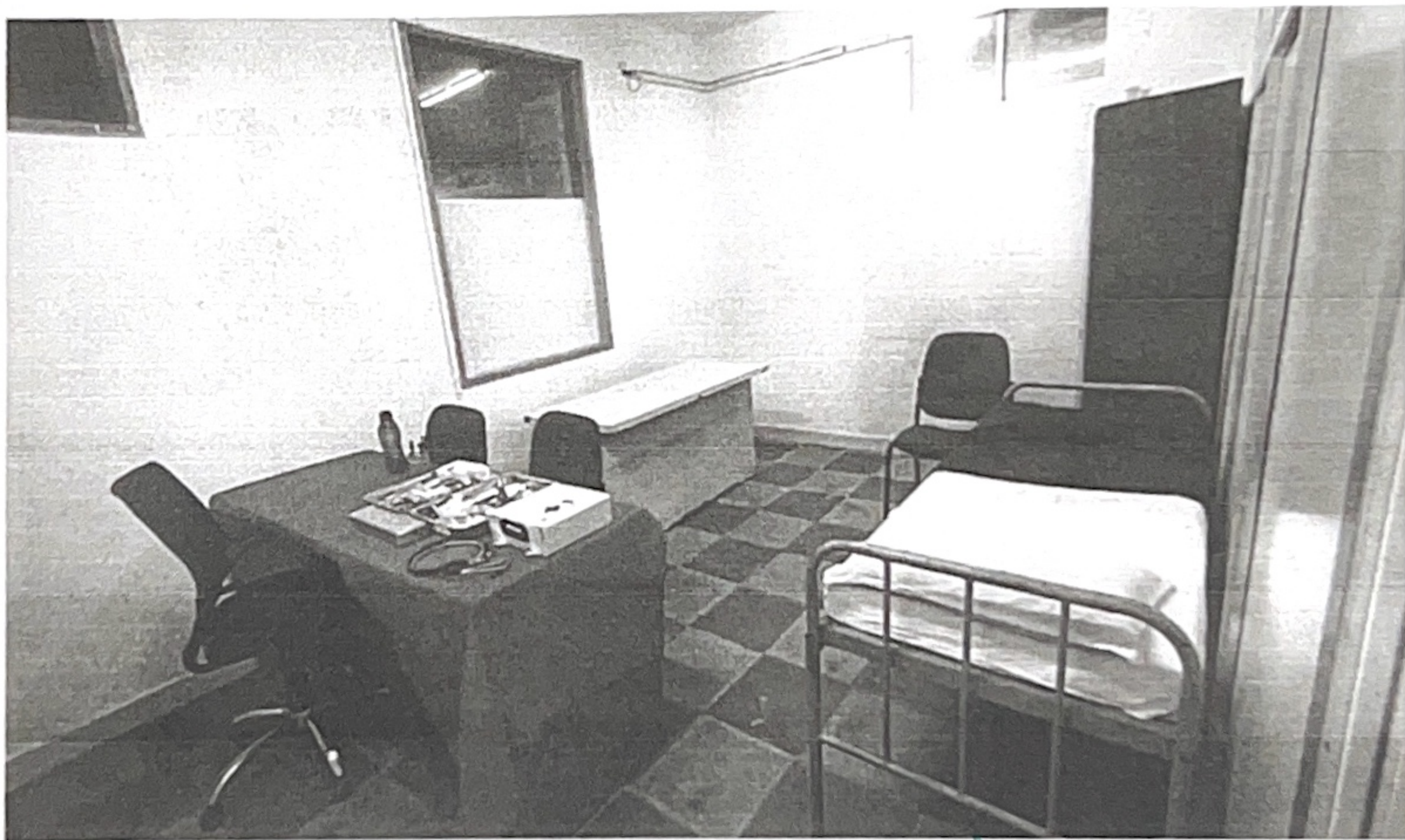
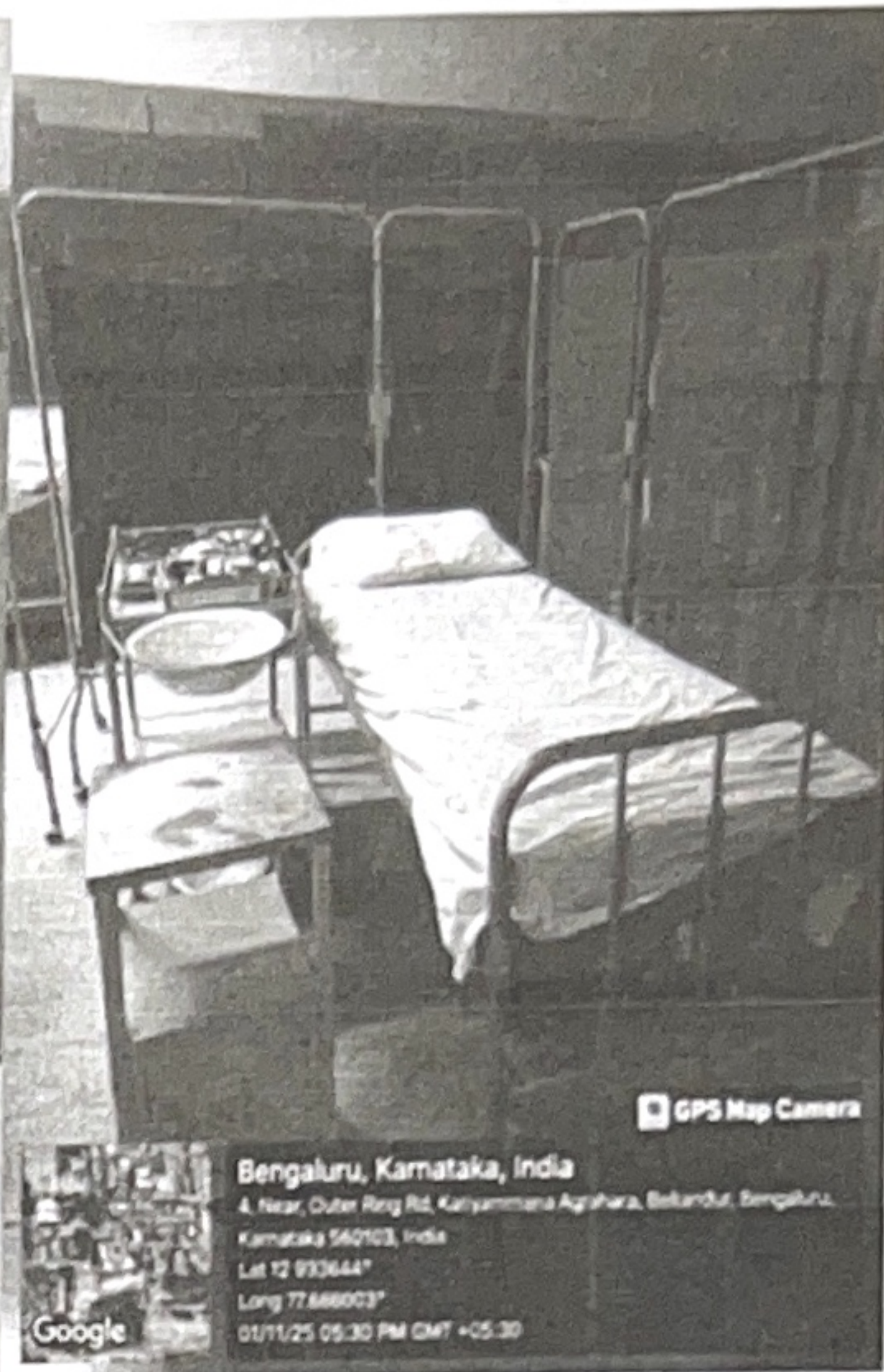
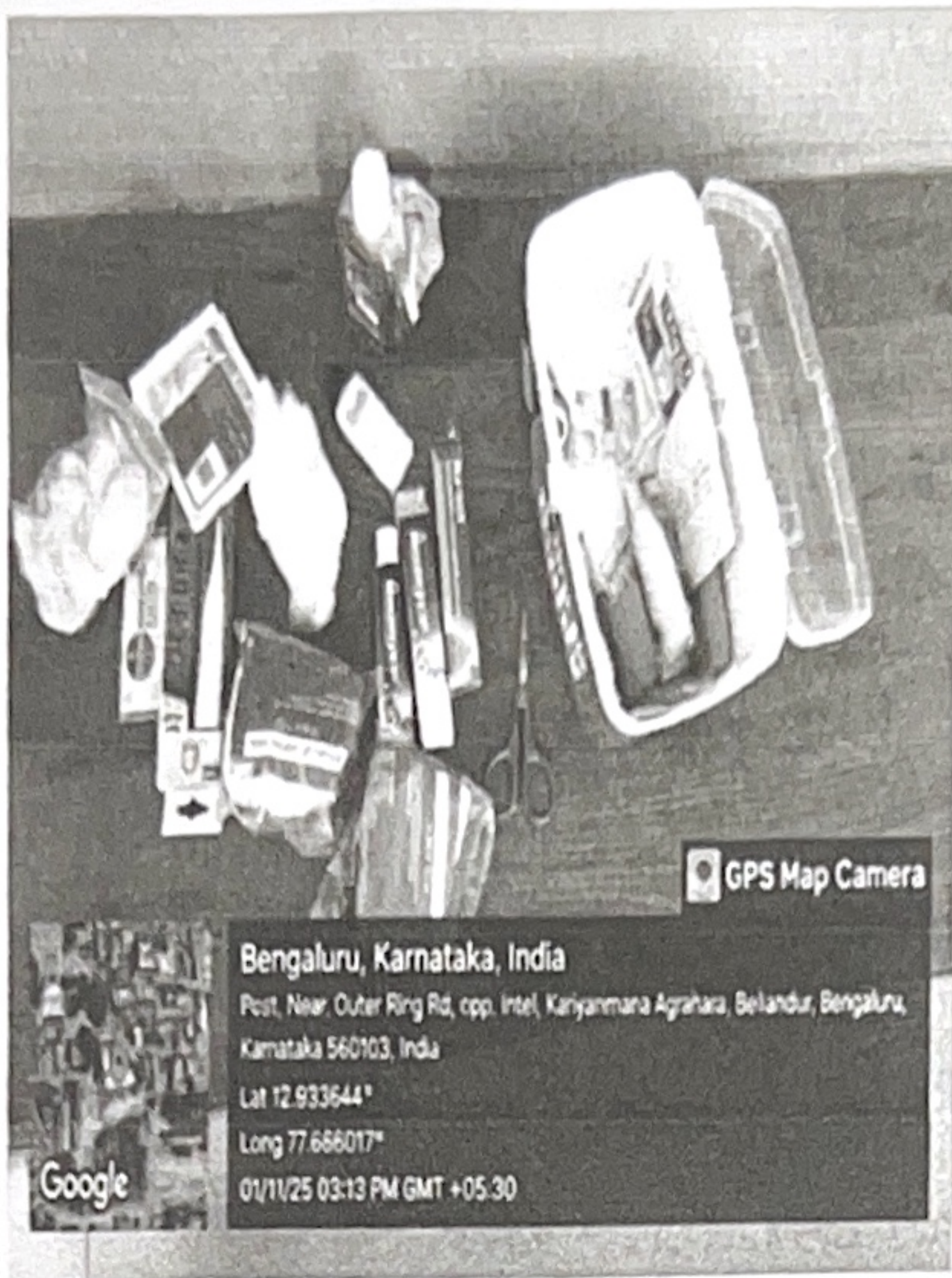
## **FIRST AID**

- e) 20 % Discount on Annual Health Checkup for Students/ Staff & their dependents (Non Sr. Citizens).
- f) 20 % Discount on Annual Health Checkup for Sr. Citizen Patients exceeding the age of 60 years.
- g) 24/7 Ambulance services for OPD/IPD.
